




Riverside County



Scope of Problem - Rural

- 2nd Largest County in CA & 2nd Fastest Growing in the Nation
 - Over 7,200 square miles in area
 - 6,531 in the Unincorporated section
- 256,767 Parcels in the Unincorporated area
 - 167,496 Improved parcels
 - 89,271 Unimproved parcels
- 2 Million people live in Riverside County
 - Over 500,000 in the Unincorporated area

Scope of Problem - Urban

Over 62.24 square miles in area

- 220,813 Population
 - 238,609 daytime population
- Over 30,000 renters
 - Approximately 900 multi-family rental units
 - Approximately 3,000 single family rental units

What is Code Enforcement in San Bernardino City?

Past -

Linear approach thru administrative routes; overwhelmed officers, overwhelmed city attorney and cumbersome legal process & PANDEMIC

Present -

Parallel approach thru administrative, criminal and civil remedies, adjusted officer case load and sharpened legal process



In response to constituent complaints relating to blighted conditions, Neighborhood Enforcement Teams respond and investigate concerns regarding health and safety, zoning, and public nuisances as well as other code violations.



Community Partnerships and Code Enforcement


- Code Enforcement and local law enforcement create a partnership to better serve the community
- Community Policing is not a program or a series of programs, but rather a philosophy
- Community Policing is the belief that by working together,
 WE can accomplish what neither can accomplish alone.
- By combining efforts communities have seen a reduction in crime and an improvement in their quality of life.

Community Based Partnerships

A 99 % prosecution success rate came as a result of these community-based programs (cultivating a good witness). Conviction penalties have included monetary fines, confinement sentencing, or probation with search terms.

Code officers were instrumental in the removal of over 40 tons of illegally dumped material.



- Leadership begins with me






Leadership
