

### Recreational Vehicle (RV)


Term RV encompasses motorhomes, trailers, and campers—all of which continue to be reported as dumped/abandoned in a variety of locations. RV definition available in <u>HSC Sec 18010</u> [DMV 6.055]. A specific <u>RV Issues</u> section is available given the significant statewide problems around this type of dumped/abandoned vehicle. ### Vessel Distinction (Watercraft)

Boats are commonly referred to as "vessels" by law. Definitions and many laws for vessels start at <u>VEH Sec 9840</u> and commence with <u>VEH Sec 10554</u>. In some instances vessels are treated similar to other vehicles when stolen or recovered since vessel registration is required for use on California waterways.

# Circumstances

<u>Abandoned Vehicles Guide (US DOJ)</u><sup>1</sup> divides factors that contribute to abandonment:

#### **Cost of Operating and Disposing of Vehicles**

- · Value of scrap metal
- · Cost and convenience of legitimate disposal
- · Cost of repair and insurance
- · Cost of safety and emissions compliance
- · Low-quality and "orphaned" vehicles
- · Natural disasters

#### Vehicle Regulation and Licensing Procedures

- Auto theft and insurance fraud
- Auctions of low-value vehicles
- · Registration and licensing procedures
- Long-term or unlimited parking in public facilities

### **Other Circumstances**

- Residents unaware of options
- Used as shelter
- Location/Process
  - Property (private/public easements, fed/state lands)
- Ease of removal (ditches & waterways)
  - Equipment availability
- Community Transportation
- Community Caretaking

## **Personal Property**

[serialized property] Since vehicles are personal property [CIV Div. 2] certain rights apply, as well as <u>lien stipulations</u>.



Upon discovery, (abandoned) vehicles are "usually tagged, and efforts are launched to identify the owner."<sup>1</sup> Some time must elapse between when a vehicle is tagged and when it can be removed.<sup>1</sup> Then, the vehicle is often stored for some time before its ultimate disposition, while efforts to identify a registered owner continue.<sup>1</sup>



# Classifications

#### **Abandoned Vehicle**

"A vehicle is considered to be 'abandoned' if it is left on a highway, public property, or private property in such inoperable or neglected condition that the owner's intent to relinquish all further rights or interests in it may be reasonably concluded. In reaching a reasonable conclusion, one must consider the amount of time the vehicle has not been moved, its condition, statements from the owner and witnesses, etc."

California Highway Patrol Handbook Chapter 4

#### **Public Nuisance Vehicle**

"Any vehicle that is abandoned, wrecked, dismantled, or any inoperative part thereof that is on public or private property, not including highways, and that creates a condition tending to reduce the value of private property, promotes blight and deterioration, invites plundering, creates fire hazards, constitutes an attractive nuisance endangering the health and safety of minors, harbors rodents and insects, or jeopardizes, health, safety, and general welfare is a public nuisance."

California Highway Patrol Handbook Chapter 4

#### Junk Vehicle

"A junk vehicle is one which has been dismantled because it was wrecked, abandoned, or inoperable." [DMV 19.015]

#### Abated Vehicle

A vehicle determined to be a public nuisance because it was abandoned, wrecked, dismantled, or inoperative and was removed by ordinance of a city or county [VEH Sec 22660].

#### What is a Dismantled Vehicle?

Dismantled shall mean the condition of a vehicle which has been taken apart, or disassembled into pieces, and/or stripped, or otherwise deprived of any of its integral parts or equipment.

(See Section 6.56.120 of the Sacramento County Code)

#### What is an Inoperative Vehicle?

Inoperative refers to the condition of a vehicle which is physically incapable of working, functioning, or otherwise operating.

(See Section 6.56.130 of the Sacramenta County Code)

#### What is a Wrecked Vehicle?

County Code)

wrecked vehicle consists of disordered or broken remains, or which has been brought to a physically impaired or unsound condition, or other ruinous state by reason of collision, crash, or other forceful impact.

## Notice/Intention to Abate, Violations

Removal of Parked and Abandoned Vehicles Authority to Remove Vehicles [VEH 22650 - 22711]

#### Examples

- Parked or left standing on a highway, blocking or a hazard
- Parked blocking driveway
- Parked blocking fire hydrant
- Parked or left standing on highway for more than 4 hours
- Driver arrested
- Illegally parked, no license plates or registration
- Parked in violation of local ordinances/road repair/construction
- Parked over 72 hours
- Parking prohibited by local ordinances or resolution
- Vehicle registration expired over 6 months
- Removal from private property
- "Abandoned", "wrecked", and/or "dismantled" condition.
- Within 7 1/2 ft of rail

#### Safety & Environmental Impact

In establishing procedures for the abatement and removal of abandoned vehicles, the department shall give priority to the removal of abandoned vehicles from corridors of the state highway system, from public lands and parks, and from river and wildlife areas.

#### Parking

#### What is the 72-Hour Parking Rule?

No person shall park or store a vehicle upon any highway or alley for more than seventy-two consecutive hours, or move and repark such vehicle on any highway within three hundred feet of the original parking site, unless such vehicle is maintained in an operable condition and was actually driven.

(See Section 10.24.070 of the Sacramento County Code)

#### Location

- Public/Private Property
- Public Nuisance

#### Notice Exemption

If the owner authorizes the removal, the vehicle is inoperable and/or incapable of tow, and the value is less than \$200 and a public nuisance there is no need for the **10-day notice**. [VEH Sec 22661]

## **Project Distinction - Low Value and Lower Tier Value**

 Low value vehicles are classified as \$500 or less [VEH Sec 22670] for the purposes of lien sales.

## Lien Stipulations (Vehicle Value), Holding Periods

- \$500 or less
- \$4,000 or less Short Lien (days)
- \$4,001+ Long Lien (+30 days)





## RVs

### More significant problem

- Removal
- Storage space (& longer lien times)
- Lack/no disposal/dismantling options (no cost recovery)
- Larger Community Impact
  - Blight, Nuisance
  - Leaking, Hazards
  - Other sanitation concerns



## City of Los Angeles – Removal/Storage

'Starting to see towers hands tied—can't take them' <u>IDTAC</u> <u>Nov 2023 Notes</u>

### Press 4/11/24

"Mayor Bass is locking arms with partners in all levels of government to address RV encampments. She expanded Executive Directive 3 to address RV encampments by increasing the City's capacity to tow, store, and dismantle surrendered vehicles. She is also sponsoring state legislation that streamlines the City's ability to lease property from the California Department of Transportation (Caltrans) at a reduced rate to store RVs while their former inhabitants receive services to transition into housing."

## City of Los Angeles – Dismantling

**RV Pilot Program** ...conducted a pilot program with the Los Angeles Department of Sanitation (LASAN) and a local recycler to experiment another way to dismantler RVs:

"The program provided four dumpsters, weekly to SA Recycling in Sun Valley to assist in the recycling of abandoned and dilapidated RVs. The program had some success in the dismantling of qualified RVs, but the current situation has expanded far beyond the capabilities initially envisioned within that pilot program. The program lacked citywide implementation and was only available to a limited group of OPGs. Logistically, LASAN had difficulty delivering and retrieving dumpsters from an operational scrap yard and the dumpsters could not be filled to their total volume capacity due to damage to the dumpsters and transportation (overflow) complications. Currently, the funds earmarked for the program have been exhausted."<sup>6</sup>

Upon RFP the city had difficulty finding "any qualified vendor capable of handling the properly regulated and environmentally responsible dismantling of RVs." Thus:

*Vehicle Recycling Program* ... "direct discussions" ensued with "a proven industry leader" that will help make-up the proposed program. Contractor can "can salvage at least 15 RVs per day."<sup>6</sup>

## Addressing the Issue

"In most cases, an effective strategy will involve implementing several different responses. Law enforcement responses alone are seldom effective in reducing or solving the problem."

"Most strategies for dealing with abandoned vehicles will require coordination with agencies and other organizations beyond police. Because so many different stakeholders are involved in the problem, it is usually necessary to work with different individuals and organizations."



## **Response Options (Strategies) – Best Practices**

#### Abandoned Vehicles Guide<sup>1</sup>

#### Prevention

- · Making legitimate disposal cheaper and easier
- Using amnesty campaigns
- Promoting private junk-car collection services
- Use publicity to promote legitimate disposal
- · Increasing the threshold value for scrapping vehicles
- · Increasing minimum bids at car auctions
- · Working with low-end used-car dealers
- · Adjusting rules for parking and street-cleaning
- · Securing dump sites
- Assisting property owners at sites where people dump cars
- · Assessing cost-of-disposal fees
- Anticipating seasonal abandonment

#### Cleanup/Reduction

- · Identifying and reporting abandoned vehicles
- · Coordinating with other agencies
- Removing derelict vehicles as quickly as possible
- Establishing routines for long-term parking facilities
- · Cleanup in abandoned vehicle "sweeps"
- · Use community volunteers
- Publicizing the problem

# **Strategies (Brainstorm)**

"Responsibility Ticket"

In the City of Oakland and San Joaquin County laws were passed to crackdown on the most recent user of a vehicle (prior to its abandonment) as opposed to charging the registered owner. Currently cameras systems have proven difficult when attempting to identify individuals.

"Partner w/ Collection/Donations Services" Non-profits and other stakeholders hold events raise/money for large cleanups, which can also create awareness around the issue.

"Revisit DMV process for residents" Ensuring those who seek Collection/Donations services are not turned away – what this looks like.

"Inactive military facilities for temporary RVs storage"

Reregistration of salvageable and abandoned vehicles removed by a local abatement procedure may be permitted when donated to a correctional institution for restoration and rebuilding. [DMV 5.120]

"Dismantling used for training" Private company owner shares his openness to have his company 'positioned to help dismantle or refurbished if possible.'

Reuse

"Market for RV shells" Used as creative housing.

#### Dismantling

Components of RV like mattress, etc. parsed to alleviate disposal costs. Working w/ CUPAs/programs

- Iimited effectiveness <u>Abandoned Vehicles Guide (US DOJ)</u><sup>1</sup>
  - increasing fines for vehicle abandonment
  - increasing fees for collecting unwanted vehicles

# Legislative efforts

Product Stewardship, Extended Producer Responsibility (EPR)

The <u>Directive on end-of-life vehicles</u> (ELV Directive) sets clear targets for ELVs and their components. It also prohibits the use of hazardous substances when manufacturing new vehicles (especially lead, mercury, cadmium and hexavalent chromium) except in defined exemptions when there are no adequate alternatives. The exemptions are listed in annex II of the Directive.

Since this Directive was introduced, several amendments have been made (for more information, see amendments below). The EU has also introduced several related rules such as the <u>Directive on the</u> type-approval of motor vehicles regarding their reusability, recyclability and recoverability.

A review of the ELV Directive was launched in 2021, resulting in a proposal for a new regulation in 2023.

Variety of stakeholders may be dismantling. What constitutes a dismantler is not straightforward.




If dismantling, licensing among other protocols required though certain expectations may apply.

#### Vehicle Dismantlers Industry Strike Team (VDIST)

"Pursuant to California Vehicle Code §11545, the Department of Motor Vehicles (DMV) Investigations Division (INV) created a multiagency collaboration to coordinate enforcement and compliance activity related to unlicensed and unregulated automobile dismantling, including tax evasion, environmental impacts, and public health impacts."

SB 366, Umberg. Automobile dismantling: task force. is slotted until January 25, 2025 unless extended.
